To the Members of Pine Lakes Estates Homeowner's Association

The PLEHOA Board would like to remind everyone that the Bylaws and Covenants that were passed in the February 2020 annual meeting are binding. The purpose of changes made was to preserve and protect our community's current lifestyle and property values.

Most of the changes revolved around the selling, buying and renting of Estate properties as noted in the Covenants, Article II, 2.01. A majority of the Homeowner's Association membership agreed that there was a need to screen potential Estates buyers and renters. The Board proposed that if the required notice was given by any member accepting a purchase offer or rental lease on their property, the Board would promptly process the approval or denial of that sale or rental. The Board then created a Committee (comprised of 2 Board members and 3 HOA members) to work to implement the process for Board consent.

Covenants Article II, 2.01 requires that all prospective home buyers or renters complete the attached application form for HOA Board consideration prior to the closing or occupancy of any Estate property. Failure to submit a completed application and receive consent could result in litigation, a delayed closing and/or possession. Board approvals or denials will not take more than five days from time of submittal; however, most will be completed within 48 hours.

It is imperative that every Estates HOA member follow the instructions and the intent of the Covenants (Article II, 2.01). Prompt notice to the Board of your intent to transfer title, accept a sale offer, or rent your home is essential. The required paperwork must be filled out completely and approval must be obtained.
